Aldi is recalling various Harvest Morn High Protein Bars because they contain milk and/or peanuts and/or soya which may not be emphasised in bold type on the label. This means the products are a possible health risk for anyone with an allergy or intolerance to milk or milk constituents, an allergy to peanuts and/or an allergy to soya.

## About allergy alerts

Sometimes there will be a problem with a food product that means it should not be sold. Sometimes foods have to be withdrawn or recalled if there is a risk to consumers because the allergy labelling is missing or incorrect or if there is any other food allergy risk. When there is a food allergy risk, the FSA will issue an Allergy Alert.
