

# Update 1: Wanis recalls Tropical Sun Semolina Fine and Coarse because of undeclared wheat (gluten)

Wanis is recalling Tropical Sun Semolina Fine and Coarse products because they contain wheat (gluten) which is not mentioned on the label. This means the products are a possible health risk for anyone with coeliac disease, and/or an allergy or intolerance to wheat or gluten. This recall has been extended to include the Semolina Coarse product.
