SPAR Northern Ireland has extended its recall of cooked chicken products to include additional batches because *Listeria monocytogenes* has been found in them.

## Risk statement

The presence of *Listeria monocytogenes* in the above products.

Symptoms caused by this organism can be similar to flu and include high temperature, muscle ache or pain, chills, feeling or being sick and diarrhoea. However, in rare cases, the infection can be more severe, causing serious complications, such as meningitis.

Some people are more vulnerable to listeria infections, including those over 65 years of age, pregnant women and their unborn babies, babies less than one month old and people with weakened immune systems.

## Action taken by the company

SPAR Northern Ireland is recalling the above products. Point of sale notices will be displayed where the products are sold. These notices explain to customers why the products are being recalled and tell them what to do if they have bought the products. Please see the attached notice.
