Compliance status

This website is partially compliant with the [Web Content Accessibility Guidelines version 2.2](#) AA standard, due to 'the non-compliances' listed below.

Page Titled (A)

- Pages did not have titles that described the topic or purpose of the page.
- WCAG Reference: 2.4.2 Page Titled (Level A)

The same title has been used across multiple pages which means that the title cannot be used to distinguish among the pages. The page title does not reflect the contents of the page which means some users may be unable to determine the subject or purpose of page content. Screen reader users may rely on the page title along with the main page heading to identify the page and understand the page content and purpose.

Emphasised Text (A)

Information, structure, and relationships conveyed through presentation were not programmatically determined or available in text.

WCAG Reference: 1.3.1 Info and Relationships (Level A)

Bold font styling has been used to emphasise text. However, this visual distinction is not programmatically determinable for it to be presented to screen reader users.

Parsing (A)

Elements were present that did not have complete start and end tags, were not nested according to their specifications, contained duplicate attributes, or had non-unique IDs.

WCAG Reference: 4.1.1 Parsing (Level A)

The role of 'presentation' has been used on a element. This will override its semantic role as an unordered list element. This means that the child elements are not associated with a direct parent (or) element. Therefore, the semantic structure of this content may not be programmatically determinable to assistive technologies for it to be presented to users.

Labels did not sufficiently describe the topic or purpose of the content.

WCAG Reference: 2.4.6 Headings and Labels (Level AA)

The buttons labels do not clearly describe the component purpose. Multiple controls have the same label, so their individual purpose is not able to be determined from the label alone. Screen reader users encountering the link out of context, for example, when filtering the page by element type, will have to switch navigational methods, and search through the surrounding page content to identify the purpose of the buttons.

Link Purpose (Link Only) (AAA)

A mechanism was not available to allow the purpose of each link to be identified from link text alone.

WCAG Reference: 2.4.9 Link Purpose (Link Only) (Level AAA)
