1. SUMMARY

This report contains a summary of acrylamide and furan concentrations measured in UK retail food samples purchased between the period November 2011 – December 2013.

- Samples were supplied to Premier Analytical Services² by an independent contractor in accordance with a sampling and analysis plan agreed with the UK Food Standards Agency. Where necessary, foods were cooked according to the manufacturers' guidelines prior to analysis.
- The total number of retail products sampled during the survey was 556 and represented the 10 food groups as specified in Commission Recommendation (EU) No. 2010/307 on the monitoring of acrylamide in food.
- All analyses were carried out using accredited methods: 544 measurements were made for acrylamide and 266 for furan.
- For this 2011- 2013 period, the number of products found to contain acrylamide levels that exceeded the 'Indicative Values' (IV) for their food category as specified in the most recent Commission Recommendation (2013/647/EU) was 37.
- Where possible, a comparison of annual survey means was made with previous survey data (since 2007).
 - \circ Crisps, soft bread and biscuits and crackers showed a tentative decreases in annual mean acrylamide concentration (R² ranged from 0.32-0.76);
 - $\circ~$ Infant cereals (excluding biscuits and rusks) showed a tentative increase in mean concentrations (R²=0.72)
 - No discernible trends or no change in annual means could be determined for French fries sold as ready to eat, potato products for home cooking, breakfast cereals, roast coffee and baby foods in jars / pouches

3. BACKGROUND

Acrylamide is an industrial chemical widely used to make polymers for applications in paper making, soil conditioning, water treatment and sealants. Since the discovery of acrylamide in cooked foods extensive efforts have been made by researchers in the food industry and academia to understand and control its formation. It is now believed that acrylamide is formed as part of the Maillard reaction, a series of reactions that take place when amino acids react with reducing sugars to give much of the colour and flavour characteristics of heated foods. Acrylamide is formed from the reaction of the amino acid asparagine with reducing sugars and other reactive chemicals generated during the course of the Maillard reaction. Asparagine is an essential amino acid and occurs naturally in all plant materials together with naturally occurring reducing sugars. The amounts of acrylamide formed in foods are subject to the laws governing all chemical reactions and depend on e.g. the relative amounts of each reactant, the applied temperature and duration of cooking. Foods naturally high in these precursors can therefore form acrylamide as a result of cooking and processing, e.g. during drying, frying, baking, grilling, roasting, and toasting. Hence significant amounts of acrylamide have been measured in both home cooked and processed foods such as potato crisps, French fries, crispbreads and coffee. Acrylamide has been classified by the International Agency for Research on Cancer as 'probably carcinogenic in humans' and the Joint FAO/WHO Expert Committee on Food Additives (JECFA) concluded that levels of dietary exposure to acrylamide indicate a human health concern. Because of this, experts have advised that dietary exposure to acrylamide should be as low as reasonably practicable.

Commission Recommendation (EC) No. 2007/331 of 3 May 2007, on the monitoring of acrylamide levels in food, set out a three-year monitoring programme (2007 – 2009) for acrylamide in certain foodstuffs. This was followed by Commission Recommendation (EU) No. 2010/307 on the monitoring of acrylamide in food which placed a requirement on the Agency to obtain further monitoring data on acrylamide in UK retail samples. So far, the results for years 2007, 2008 and 2009 have been compiled and reported by the European Food Safety Authority (EFSA).

FoodDrinkEurope³ maintains and publishes the Toolbox, which provides guidance to industry on intervention steps that may be helpful in reducing acrylamide formation in French fries, crisps, bread, bakery wares, breakfast cereals, and coffee. While efforts by the food industry and member states to reduce acrylamide levels in foodstuffs are ongoing, it has been deemed appropriate to continue the collection of monitoring data to ascertain the efficacy or effects of these measures.

Like acrylamide, furan is also widely used in the chemical industry for the preparation of e.g. resins, lacquers and agricultural and pharmaceutical chemicals. While furan has been known as a flavour volatile for many years, e.g. in coffee, only limited data exist for concentrations in other foods. Various precursors such as reducing sugars, vitamin c, organic acids, carotenes and polyunsaturated fatty acids may lead to furan formation during heating but the underlying mechanism are not fully understood. Furan has been classified by the IARC as a possible human carcinogen. Evidence indicates that the latter may occur via a genotoxic mechanism. In 2007, the European Commission recommended that member states should carry out monitoring for the presence of furan in heated foods⁴.

The results from this three year survey support the Agency's current Strategic Plan (to 2015) in ensuring that foods produced or sold in the UK are safe to eat. It also meets the requirements of the Commission Recommendations for member states to monitor amounts of acrylamide and furan in retail foods and further supports Agency work to identify and reduce the impact of potential new and

re-emerging risks. Full details and final results for the previous 2010-2011 acrylamide / furan survey and links to earlier (2007, 2008, 2009) surveys and can be accessed via the Agency website⁵.

4. METHODS

4.1 SAMPLES

Samples representing the ten food groups specified in Commission Recommendation 2010/307/EU were collected by Ventress Technical Limited and delivered to Premier Analytical Services for analysis. Details of the sampling plan are given in Table 4 of the appendices (see section 7.1).

All samples received at the laboratory were prepared and stored according to the Food Standards Agency "Guidelines for undertaking surveys"⁶. Potato products from Food Category 3 were cooked according to manufacturers' guidelines prior to the determination of acrylamide; because of the volatile nature of furan, coffee and coffee substitutes were tested for furan before and after preparation for consumption. Further details of the sample preparation procedures used are given in section 7.2 and Table 5 and Table 6.

4.2 ANALYSIS

Analysis of samples for the Nov 2011-2013 survey was carried out using UKAS accredited methods: the measurements of acrylamide and furan were based on the guidelines laid down in Commission Recommendations 2007/331/EC and 2007/196/EC. All test results were obtained from methods that used labelled isotope internal standards for recovery correction in line with Food Standards Agency Guidelines¹⁸ and EC recommendations^{7,8}. Further details of the methods together with the analytical quality assurance procedures and measurement uncertainty can be found in the appendices (see sections 7.2 and 7.3).

5. RESULTS AND DISCUSSION

A total of 556 samples were received over the period November 2011 - November 2013 for the analysis of acrylamide and furan in accordance with the test requirements given in Table 1. Potato products for home cooking and microwaveable popcorn were cooked according to manufacturers guidelines prior to analysis. Coffee and coffee substitutes requiring furan analysis were tested as received and as consumed to assess potential losses of volatile furan during preparation (see appendix 7.2 for cooking / preparation conditions).




Figure 1. Acrylamide in product categories / sub categories (logarithmic scale) in order of increasing concentrations: mean, range and number of samples (in parentheses) for the period 2011-2013.

Figure 1, which has been ordered by increasing mean concentrations (average of all data 2011-2013), shows that categories / sub-categories with the lowest mean amounts of acrylamide (<100 μ g/kg) were: novelty gingerbread (Cat 10); pastries (Cat 10); tortillas / corn snacks (Cat 10); processed cereal baby foods (Cat 9); dates and olives (Cat 10); soft bread (Cat 4); and baby foods other than processed cereal based foods (Cat 8). Product Categories with the highest mean concentrations of acrylamide for the period 2011-2013 (>500 μ g/kg) included: the popped potato chips (Cat 10); Vegetable crisps (Cat 10); Potato crisps (Cat 2); Baked potato from fast food outlets (Cat 10); and prefabricated snacks (Cat 10).

5.1.1 Products prepared from fresh potato (Categories 1, 2, and 3).

Products prepared from fresh potato were sampled biannually over the period Nov 2011-Nov 2013 to assess the effects of seasonal variation on acrylamide generated during cooking (see Table 4). The approximate cook times and pre-processing conditions for French fries sold as ready to eat (Category 1) were supplied by each outlet. French fries for home cooking (chilled and frozen) were cooked using domestic appliances according to manufacturers guidelines.

Category 1. Acrylamide amounts in 100 samples of French fries sold as ready to eat over the period Nov 2011-Nov 2013 ranged 38-1091 μ g/kg (mean 212 μ g/kg), consistent with the wide range of preprocessing techniques (e.g. chipping/soaking/blanching), cooking conditions (time/temperature) and seasonal factors. The total number of samples exceeding the Indicative Value⁷ of 600 μ g/kg for this Category was three.




Figure 2. Comparison of seasonal means for acrylamide in category 1 thin and thick cut French fries with data from previous surveys (Mar 2007 – Mar 2011). Vertical bars are ± 1 standard error; no sampling was undertaken in Mar 2010.

The seasonal trends for both thin and thick cut French fries over the period Nov 2011-Nov 2013, together with those from the previous Agency surveys (Mar 2007-Mar 2011), are given in Figure 2. The ratio of thin to thick cut chips was 1:3.

Category 2. Acrylamide measured in 50 samples potato crisps over the period Nov 2011-Nov 2013 ranged from 150-2231 μ g/kg (mean 717 μ g/kg). The total number of samples exceeding the Indicative Value of 1000 μ g/kg for this Category was 13.




Figure 3. Comparison of seasonal means for acrylamide in category 2 crisps with data from previous surveys (Mar 2008 – Mar 2011). Vertical bars are ± 1 standard error; no sampling was undertaken in Mar 2010.

Figure 3 shows the season trends for Nov 2011-Nov 2013 together with those from previous Agency surveys (Mar 2008-Mar 2011): Over the period 2008-2013, there was a slight trend towards decreasing seasonal means (R^2 =0.32).

Category 3. A total of 72 potato products (62 prepared from fresh potato and 10 prefabricated products) for home cooking were prepared according to manufacturers on-pack guides using e.g. domestic oven, grill, deep fat fryer or microwave.




Figure 4 Comparison of seasonal means (log scale) for acrylamide in category 3 potato products prepared from fresh potato (62/72 samples) with data from previous surveys (Mar 2008 – Mar 2011). Vertical bars are ±1 standard error; no sampling was undertaken in Mar

Amounts of acrylamide for the whole category (mean 336 μ g/kg) ranged from 9-3067 μ g/kg. Figure 4 shows the season trends for the Nov 2011-Nov 2013 products prepared from fresh potato together with those from previous Agency surveys (Mar 2008-Mar 2011, excluding prefabricated products): there were no discernible seasonal or long term trends.

5.1.2 Soft bread (Category 4 – 20 samples).

Samples (e.g. plant produced white and wholemeal loaves, rolls and baguettes and speciality products such as soya and linseed, sunflower and barley, olive ciabatta) were taken in 2012 and again in 2013.

Amounts of acrylamide (see Table 2) for the period ranged from 6-45 μ g/kg (mean 20 μ g/kg). As expected, white bread had a lower mean acrylamide content (16 μ g/kg) compared to wholemeal bread (33 μ g/kg) (see Table 2), presumably due to the lower asparagine content of white flour. None of the samples were found to exceed the Indicative Values set for this category given in Appendix 7.4.




Figure 5. Comparison of annual mean acrylamide concentrations in retail soft bread with data from previous surveys (2007-1010). Vertical bars are ± 1 standard error; no sampling was undertaken in 2011

The annual trends for the 2012-2013 products together with those from previous Agency surveys (2007-2010) are given in Figure 5.

5.1.3 Breakfast Cereals (Category 5 – 20 samples).

.

A total of 20 samples of breakfast cereal were purchased in each of the survey years 2012 and 2013. The total number of samples exceeding the Indicative Values for this Category (see Appendix 7.4) was 11 (nine from "bran products and whole grain cereals, gun puffed grain"; and two from "wheat and rye based products").




Figure 6. Comparison of annual mean acrylamide concentrations in retail breakfast cereals with data from previous surveys (2007-1010). Vertical bars are ± 1 standard error; no sampling was undertaken in 2011

The annual trends for the 2012-2013 sample means together with those from previous Agency surveys (2007-2010) are given in Figure 6.

5.1.4 Biscuits and crackers (Category 6 – 20 samples).

This Group comprised four of the five sub-categories according to the Commission Recommendation (2010/307/EU), i.e. crackers, crispbreads, wafers and other biscuits (the Gingerbread category was placed in Group 10 as the UK product / recipe was different to that consumed in Europe). Within this category, the "Other" biscuits sub-category had the highest mean acrylamide concentration (survey mean 345 μ g/kg, range 27-1328 μ g/kg – see Table 2) with the ginger biscuits accounting for the highest individual amounts.

The total number of samples exceeding Indicative Values for this Category (see Appendix 7.4) was five (two from "Biscuits and wafers"; three from "Crackers with the exception of potato based crackers").




Figure 7. Comparison of annual mean acrylamide concentrations in retail biscuits and crackers with data from previous surveys (2007-1010). Vertical bars are ± 1 standard error; no sampling was undertaken in 2010

Figure 7 shows the results for the samples taken in 2012 and 2013 together with those from previous Agency surveys (2007-Mar 2011): Over the period 2007-2013 this category showed an apparent trend towards decreasing annual means ($R^2=0.76$).

5.1.5 Coffee (Category 7 – 20 samples).

This Group comprised the three sub-categories according to the Commission Recommendation (2010/307/EU), i.e. roast coffee, instant (soluble) coffee and coffee substitutes. Measurement of acrylamide was carried out on the coffee as received in order to assess mitigation measures on an annual basis. Hence the amounts of acrylamide did not represent values as consumed in the brew, which would be much reduced by dilution with water.

Table 2 shows that instant coffees and coffee substitutes had the highest mean acrylamide contents. None of the samples were found to exceed the Indicative Values set for this category given in Appendix 7.4.

A comparison of annual means with data from previous surveys is given in

Figure 8: note that instant coffees and coffee substitutes were not included in the earlier (2007-2009) Agency surveys.




Figure 8. Comparison of annual mean acrylamide concentrations in retail roast, instant and coffee substitutes with data from previous surveys (2007-1010). Vertical bars are ± 1 standard error; no sampling was undertaken in 2011

5.1.6 Baby foods other than processed cereal based foods (Category 8 – 20 samples)




Figure 9. Comparison of annual mean acrylamide concentrations in baby foods with data from previous surveys (2007-1010). Vertical bars are ± 1 standard error; no sampling was undertaken in 2011

This category accounted for the lowest mean acrylamide concentrations in the survey (see Figure 1) and included infant foods packaged in jars and pouches. The annual mean results were within the range of means measured in previous UK surveys (see Figure 9). None of the samples were found to exceed the Indicative Values set for this category given in Appendix 7.4.

5.1.7 Processed cereal based foods for infants & young children (Category 9 - 20 samples)

Samples comprising the two categories specified in the Commission Recommendation, i.e. infant biscuits & rusks and infant cereals (e.g. baby rice and porridge) were purchased in 2012 and 2013.

The mean acrylamide concentration in the 2012 infant cereals (i.e. baby rice / porridge) of 29 μ g/kg (range 11-90, n=11) was within the range of means obtained in previous UK surveys (2007-2010) although amounts were significantly higher in 2013 (mean 53 μ g/kg, range 4-278 μ g/kg , n=11). Acrylamide levels were significantly higher in the infant biscuits and rusks. A total of five samples were found to exceed the Indicative Values set for this category given in Appendix 7.4.




Figure 10. Comparison of annual mean acrylamide concentrations in processed cereal based foods and biscuits and rusks for infants and young children with data from previous surveys (2007-1010). Vertical bars are ±1 standard error; no sampling was undertaken in 2011

A comparison of annual means with data from previous surveys is given in Figure 10: note that the infant biscuits and rusks were not included in the earlier (2007-2009) Agency surveys. Over the period 2007-2013, there was a trend towards increasing mean annual acrylamide concentrations in the infant cereals (R^2 =0.72).

5.1.8 Other products (Category 10 – 50 samples).

This Group included a range of foodstuffs not defined by Categories 1-9 and for which little or no data was available from previous surveys of acrylamide in UK retail products. All samples were analysed for their acrylamide content and the results are summarised in Table 2.

Products with the lowest survey mean acrylamide levels (<100 μ g/kg) were: Novelty gingerbread; pastry; tortilla/corn snacks; dates / olives. Products with the highest survey mean acrylamide concentrations (i.e. >500 μ g/kg) included: The popped chips; vegetable crisps; baked potato; and prefabricated snacks. Indicative Values (see Appendix 7.4) had not been established for products in this category.

5.2 FURAN

Furan was measured in retail samples of breakfast cereals, biscuits and crackers, coffee and coffee substitutes, baby foods (Category 8) and selected products from category 10 (see Table 3).

Figure 11, which has been ordered by increasing mean concentrations for the survey, shows that categories / sub-categories with the lowest mean amounts of furan as consumed (<10 μ g/kg) were: Olives (canned); cereal bars / granola; novelty gingerbread; and jams / preserves. The only category with a significant amount of furan as consumed (>50 μ g/kg) was popcorn.




Figure 11. Furan in product categories / sub categories as consumed (logarithmic scale) in order of increasing concentrations: mean, range and number of samples (in parentheses) for the survey (2012-2013).

All samples from Category 7 were analysed as received and as consumed to determine potential furan losses during domestic preparation. The results from all analyses, i.e. as received and as consumed, were therefore expressed on a dry weight basis so that the effects of diluting samples during preparation could be removed (normalised) and losses due to preparation compared directly.




Figure 12. Losses of furan in roast, instant and coffee substitutes during preparation for consumption: Furan concentrations in all samples were normalised to a dry weight basis to remove dilution effects; vertical bars are ± 1 standard error.

Figure 12 shows the amounts of furan in coffee before and after domestic preparation expressed on a dry weight basis. As expected, losses of furan occurred during the preparation of all samples: approximately 50% of the furan present in roast coffee was lost during domestic preparation; losses were more variable for the instant coffees and coffee substitutes.

6. CONCLUSIONS

- Acrylamide
 - Categories / sub-categories with the lowest mean amounts of acrylamide, i.e. <100 μ g/kg), included:
 - Novelty gingerbread
 - Pastry
 - Tortilla/corn snacks
 - Processed Cereal Baby Food
 - Dates / olives
 - Soft bread
 - Baby Food other than processed cereal based
 - The highest mean concentrations of acrylamide, i.e. $>500 \mu g/kg$ were found in:
 - Popped chips

- Veg crisps
- Potato Crisps
- Baked potato
- Prefabricated snacks
- \circ Comparison of acrylamide data with that from previous surveys (since 2007) showed no significant (i.e. R²>0.9) annual trends. However the following tentative trends were determined:
 - Categories showing an overall potential decrease in annual means included:
 - Crisps ($R^2 = 0.32$)
 - Soft bread ($R^2=0.34$)

Biscuits and crackers ($R^2=0.76$)

- Categories showing an overall potential increase in annual means Infant cereals (excluding biscuits and rusks) (R²=0.72)
- Categories showing no significant change or no discernible trends in annual means included:
 - French fries sold as ready to eat
 - Potato products for home cooking
 - Breakfast cereals
 - Roast coffee
 - Baby foods in jars / pouches
- Furan
 - $\circ~$ Mean survey amounts of furan in all product categories as consumed were relatively low (< 100 $\mu g/kg$).
 - Categories with the lowest mean furan concentration (< $10 \mu g/kg$) as consumed were:
 - Olives (canned)
 - Cereal bars / granola
 - Novelty gingerbread
 - Jams / preserves
 - The highest amounts of furan (>50 μ g/kg as consumed) were found in sweet popcorn
 - When Category 7 coffee samples were prepared for consumption losses of furan were observed from all products.
 - losses were most variable from instant coffee

7.2 SAMPLE PREPARATION DETAILS AND ANALYTICAL METHODS

7.2.1 Sample preparation

All samples were prepared according to the Food Standards Agency "Guidelines for undertaking surveys"⁴. Where practical, digital images (samples and packaging) were recorded and all packaging retained.

Potato products for home cooking from Category 3 and popcorn (Category 10) were cooked according to the manufacturers' guidelines using domestic appliances e.g. oven, grill, microwave, deep fat fryer (see **Error! Reference source not found.**). The grill and oven were preheated for 5-10 minutes and a single layer of the product was applied to a baking try (placed in middle of oven) or mesh grill pan respectively; samples were typically turned at half of the recommended cooking time. Pure sunflower oil was used for frying.

Coffee and coffee substitute samples were prepared according to the manufacturers guidelines given on the packaging: retail domestic coffee preparation equipment was used as required, e.g. a cafetiere or espresso coffee maker (see Table 6**Error! Reference source not found.**).

7.2.1.1 Homogenisation

Samples requiring furan analysis, e.g. jars and packets were separated and retained for individual processing; coffee and coffee substitutes prepared for consumption were analysed immediately after the preparation cycle. These samples were not subjected to bulk homogenisation as this would have resulted in significant losses of volatile furan.

Where practical, entire samples (approximately 1kg) were homogenised for analysis:

- Category 2, 5, 6, 8 and 10 samples (excluding Category 10 Jacket potatoes see below) were homogenized directly using a food processor.
 - A laboratory mill was used for the additional processing of samples containing seeds.
 - A domestic cheese grater was used for the chocolate.
 - Stones were removed from canned prunes prior to homogenization.
- Category 4 samples were air-dried (weight loss recorded) prior to homogenising.
- Potato products from Categories 1, 3 and 10 were homogenized with water (1:2 sample/water w/w) using a high speed blender or food processor.
- Category 7 and 9 samples (ground/milled products) were mixed thoroughly prior to analysis
 - A coffee grinder was used for the whole coffee beans.

An aliquot of the homogenised sample was taken for analysis while the remainder was divided into four pots and stored at -18°C.

7.2.1.2 Homogeneity testing

Representative samples from Categories 1-10 were selected at random and the homogeneity determined by replicate (6) sodium analyses. This was based on the assumption that both sodium and the analytes of interest had an equivalent distribution in these samples. Samples were confirmed as homogeneous by comparing the relative standard deviation (RSD) of the replicate measurements with that obtained from method control samples using a statistical F-test.

Samples (2-3 g) were treated with hot concentrated nitric acid prior to determination by atomic absorption spectroscopy on a PE 2100 (Perkin Elmer, USA) according to the procedure of Gorsuch⁸. Each batch was analysed with a blank and an in-house reference material.

7.2.2 Acrylamide analysis by GC/MS/MS

Acrylamide was determined as the brominated derivative, 2-bromopropenamide, according to the method of Hamlet and Sadd⁹.

Method performance (typical): limits of detection and quantification were 0.5 and 3.0 μ g/kg respectively; the estimated value for the method uncertainty (single determination) was: ±14% at 49 μ g/kg (expanded relative uncertainty with a coverage factor of 2). A summary of the method performance data from this survey can be found in Table 7.

7.2.3 Analysis of furan

Furan was measured in samples using a headspace method adapted from the procedure of Becalski *et al*¹⁰. Pre-chilled samples were homogenised at 3°C with deionised water and an aliquot was contained in a headspace. Deuterium labelled furan (internal standard) was added and the samples incubated at 35° C prior to sampling the headspace for GC/MS analysis. Because of the volatile nature of furan all samples were analysed in duplicate: either single analyses of duplicate packs (were available) or duplicate analyses of single packs.

Method performance (typical): The limits of detection and quantification were 0.07 μ g/kg and 0.2 μ g/kg respectively; the estimated uncertainty for a single determination over the concentration range 20-100 μ g/kg furan was \pm 20% (expanded relative uncertainty with a coverage factor of 2). A summary of the method performance data from this survey can be found in Table 7.

7.3 ANALYTICAL QUALITY ASSURANCE

All analyses were performed by trained staff in a UKAS accredited laboratory operating an internal audit and review process. All the test methods were all validated in-house and accredited by UKAS (ISO 17025).

Each batch of samples (1-10 samples) included a procedural blank and an In-House Reference Material (IHRM) and / or spiked sample. Method performance was monitored by assessing the data from IHRMs and / or spiked reference materials in accordance with the rules governing Shewhart control charts¹¹ (this data is summarised in Table 7). The laboratory also participated in the FAPAS proficiency testing schemes available for acrylamide and furan (see Table 8). In addition, 10% of all samples were subjected to a repeat analysis: acceptance criteria for reporting of all results was for the duplicate measurement to be within $\pm 10\%$ of the first measurement (see Table 9).
