	a. There were accumulations of grease and dirt on the worksurface at the base of the bare wood next to the pizza oven.
	b. There was dirt on the electrical socket next to the pizza oven.
	2. Surfaces in contact with food were not in a sound condition contrary to Regulation (EC) 852/2004 Article 4. Annex II, Chapter III paragraph 2(b). A piece of untreated wood was positioned next to the pizza oven on the food preparation surface and this was in a

	poor condition with ingrained dirt and grease.
	 3. Equipment with which food is coming into contact with is not being effectively cleaned and disinfected contrary to Regulation (EC) 852/2004 Article 4. Annex II, Chapter V, para 1 (a). The food probe was not being disinfected and the wipes available were not disinfectant based and past the expiry date. 4. Food was not being protected against any contamination contrary to Regulation (EC) 852/2004 Article 4. Annex II, Chapters V, para 1(b) and IX, para 3. A wooden stick was observed in a bucket containing cut potato chips.
