The Animal Feed (Basic Safety Standards) (Wales) Regulations 2018 Summary report of stakeholders' responses

The Animal Feed (Basic Safety Standards) (Wales) Regulations 2018 consultation was issued 23 August 2107 and closed on 4 October 2017

The FSA in Wales carried out a 12-week public consultation exercise that was published on its website and sent directly to all identified stakeholder organisations.

- 1 The FSA is grateful to those stakeholders who responded and sets out in the table below responses in order of the key proposals.
- 2 The key proposals on which the consultation sought views were:
 - Prohibit the intentional addition of radioactive substances to animal feedingstuffs
 - Prohibit the import or export of animal feedingstuffs to which radioactive substances have been intentionally added
 - Allow the use of Improvement Notices for non-compliance
 - Allow for direct prosecution, where appropriate, for noncompliance
 - Allow for seizure and detention of affected animal feedingstuffs
 - Allow for powers of entry to commercial premises for enforcement officers
- 3 The Food Standards Agency's considered responses to stakeholders' comments are given in the last column of the table. A summary of changes to the original proposal(s) resulting from stakeholder comments is set out in the final table.
