#### INTRODUCTION

This guide summarises advice on the lists of non-EU countries approved for imports of fishery products and bivalve molluscs to the UK. These are non-European Union (EU) countries that have been visited by the European Commission for hygiene checks and fishery products or bivalve molluscs are permitted to be imported from these countries as indicated to the EU under specific conditions.

#### INTENDED AUDIENCE

2. The guidance is aimed at importers who wish to import fishery products and bivalve molluscs from countries outside the EU into the EU.

### **PURPOSE OF GUIDANCE**

3. The purpose of the guidance is to provide those importers who wish to import fishery products and bivalve molluscs from outside the EU with advice on the countries from which they can import these products into the UK.

#### **LEGAL STATUS**

4. These guidance notes have been produced as a signpost to certain legal requirements relating to the imports into the UK of fishery products and bivalve products from approved non-EU countries. They cannot cover every situation and you may need to consider the relevant legislation itself to see how it applies in your circumstances. If you do follow the guidance notes they will help you to comply with the law. Businesses with specific queries may wish to seek the advice of their local enforcement agency, which will usually be the trading standards/environmental health department of the local authority.

#### Using Tables 1 and 2

Two tables showing approved non-EU countries authorised to export to the UK are below. Table 1 applies to bivalve molluscs, echinoderms, tunicates and marine gastropods and Table 2 applies to fishery products. All consignments of fishery products or bivalve molluscs, echinoderms, tunicates and marine gastropods must come from authorised establishments and be accompanied by a health certificate. The health certificate for fishery products (including dead bivalve molluscs, echinoderms, tunicates and marine gastropods) is set out in Commission Implementing Regulation (EU) No 1012/2012. The health certificate for live bivalve molluscs, echinoderms, tunicates and marine gastropods is set out in Commission Regulation (EC) No 1250/2008 (see links to Regulations in the tables). For USA and New Zealand different certification requirements apply, and Table 2 gives the link to the appropriate Commission Decision and health certificate.

Notes on further import restrictions are included.

#### What does your consignment contain?

If your consignment contains bivalve molluscs (these include oysters, mussels, clams, cockles and scallops), echinoderms (these include sea urchins and sea cucumbers), tunicates (these include sea squirts) or marine gastropods (these include whelks, winkles and abalone), then refer to Table 1.

If your consignment contains fishery products such as crustaceans (these include prawns, lobsters, crayfish, crabs and shrimps), all cephalopods (these include octopus, squid and cuttlefish), aquaculture products (these include farmed salmon, trout, prawns or shrimps), but not mammals such as whales, then refer to Table 2.

#### Important information

The import of bivalve molluscs, echinoderms, tunicates and marine gastropods, in any form, to the UK will not be allowed from any country not on Table 1.

The import of fishery products to the UK will not be allowed from any country not on Table 2.

All consignments should be clearly and indelibly labelled showing the country of origin and the approved establishment number in accordance with Annex II of Regulation (EC) No 853/2004. Consignments of live crustaceans (lobster, crab, crayfish etc) imported to the UK for human consumption are subject to veterinary checks and health certification as laid down in Regulation (EU) 1012/2012. Consignments of live bivalve molluscs imported to the UK for human consumption are subject to veterinary checks and health certification as laid down in Regulation (EC) No 1250/2008.
