#### WFAC 21/04/03 FOR DISCUSSION WFAC, FSA IN WALES DIRECTOR'S REPORT – APRIL 2021

#### 1 Food Law Code of Practice

1.1 Consultation on the Food Law Code Practice in Wales closed on 25 March. Nine replies have been received, including a response on behalf of the Directors of Public Protection in Wales and the 22 local authorities, and replies from the Welsh Local Government Association, Chartered Institute of Environmental Health, Chartered Trading Standards Institute and UK Hospitality. We are currently considering the responses. Our response will be provided within three months of the consultation closing.

# 2 Food Hygiene Rating Scheme

2.1 The FSA in Wales is leading on a digital project that is using image recognition to detect the use of FHRS stickers/ratings in an online environment. The project has moved from proof of concept to further development and will inform decisions on the possible enhancement of the current scheme in Wales to the online display of ratings.

# 3 Safe Sustainable Authentic Food Wales (SSAFW)

3.1 The partnership group is scheduled to hold its next meeting on 23 June. The SSAFW COVID-19 response sub-group has been formally closed, and will be replaced by a recovery sub-group. The purpose of the recovery sub-group is to provide a forum for the FSA, local authorities and the Welsh Government to work together in the context of the operational issues associated with recovery from the COVID-19 pandemic in terms of delivering food and feed law and practice, and service delivery in Wales.

# 4 School Engagement Programme

4.1 The FSA in Wales' school engagement programme has been adapted to enable delivery remotely, in addition to face to face delivery when conditions allow. The adaptation has been welcomed by primary schools in Wales who continue to benefit from workshops disseminating key food safety messaging.

# 5 Local Authority Training

5.1 Throughout April, the FSA in Wales has been hosting virtual animal feed training for local authorities on the current issues affecting animal feed and imported feed. Recent courses have included Feed Hygiene Primary

Production/Feed labelling, surplus food used in feed and raw pet food production. The courses have been well attended by local authority officials.
